Payments received after the 7th without prior arrangements with the Academy will be considered as late payments with a penalty fee. The Academy may involve Debt Collectors and take Legal Action for overdue payments. In addition, your child may not be allowed to attend class until outstanding fees are paid in **FULL**.
6. **NO DISCOUNTS** or non-payment will be given to children who are absent on holiday or on sick leave.
7. The Academy will provide **FREE** breakfast in the morning. Children to bring own packed lunch and a light afternoon snack (no luxuries) allowed at all.
8. Bring a blanket, new facecloth every 6 months and cap/sun hat. Blankets to be washed monthly by parents
9. Your child **MUST** remain at home when he/she is suffering from any contagious disease, until he/she has fully recovered. No medication will be allowed on Academy premises. We prefer parents to administer **ALL** medication personally. Kindly deworm your child every 6 months for health reasons.
10. Provide the Academy with any relevant information pertaining to your child's health condition. All personal information will be treated as confidential.
11. A full month's written and signed notice is required when you decide to terminate your child from the Academy. **ONLY** parents who registered the child may give termination notices.
